1 PREPARATION

Ultrasound/hormone analysis controls (unlimited).

- The validity of this quotation is for six months.
- If there is no pregnancy on the first attempt, a new endometrial preparation, devitrification and transfer of an embryo will have an additional cost of €2,055.
- Donor sperm has an increase of €435.
- Due to current legislation, medication is not included and is at the patients own expense.
- A minimum of 8 mature oocytes are guaranteed to be retrieved from the donor.
- A minimum of two blastocysts is guaranteed. In the event of failure to obtain them, or if only one blastocyst is obtained and does not result in a live birth, the patient will pay €2,055, with the clinic paying the rest of the amount. In order to apply this guarantee, the following is required: Absence of male factor infertility; absence of genetic pathology and/or normal karyotype and/or normal sperm FISH result; male partner being under 50 years old; normal spermogram (in case of isolated teratozoospermia, it should be less than 98%); normal double-chain fragmentation (this is not usually required beforehand unless recommended by a doctor, but to apply the guarantee it will be requested and the result must be normal. In the event that the patient wishes to request it beforehand, it can be carried out outside of medical indication). The guarantee does not apply in mixed cycles (partner and donor sperm) and/or with PGD.
- Donor gametes (male and female) are part of the Assisted Human Reproduction Information System (SIRHA).
- After the blood withdrawal for the HERES genetic compatibility test, the patient will have three months to start the treatment. In case of cancellation of the treatment, the patient will have to pay the costs incurred up to that point (€50 per control, €120 per medical consultation, test HERES etc...).
- Treatment cancellations for hormonal, follicular development or endometrial development reasons are free of charge.
- Storage of embryos: two years after vitrification, the patient must decide if they wish to use the embryos for any of the legally authorised applications or if they wish to pay the storage fee of €435 per year.
